The Department of General Services has partnered with the Administrative Office of the Courts (AOC) to increase DVBE participation on statewide court construction projects. Senate Bill (SB) 1407 (Stats. 2008, ch. 311) authorized up to \$5 billion in bonds to build or renovate 39 courthouses in 32 counties. These projects will replace or improve courthouses with the most severe problems. It is estimated that 104,000 direct and indirect jobs will be created by projects funded by SB 1407.
